



# **Privacy Policy**

#### **Use of Personal Data**

The personal data you have indicated will be processed with a view to marketing products and services marketed by **Tincomil** - Sociedade Fabril de Tintas e Produtos Químicos, Lda. and its counterparts.

## Responsible for the processing of personal data

**Tincomil** - Sociedade Fabril de Tintas e Produtos Químicos, Lda (hereinafter referred to as **TINCOMIL** only) is responsible for the processing of your personal data, by automated means or not, from its collection, organization, storage until disposal.

**TINCOMIL** is aware of and complies with the rules laid down for the processing of personal data, which are currently laid down in Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016.

## **Purpose**

Your personal data will only be used for the purposes indicated above.

Your data will not be transmitted to others, nor will it be used for purposes other than those for which you gave your consent.

Please note that the communication of your personal data that you are carrying out to **TINCOMIL** is not mandatory by law or for any other reason. Thus, you are not obliged to provide us with your data, but if you do not, the consequence will be not receiving marketing of products and services marketed by **TINCOMIL** and its counterparts.

We point out that **TINCOMIL** has no data processor for the purposes of processing, because it does not need it, as is clear from the RPD.

#### **Duration of data retention**

Your data will be stored for a period of 3 years from the granting of this consent.

Right of access, rectification, erasure, restriction of processing, opposition to processing, request the portability of your data.

You have the right, whenever you want and free of charge, to ask TINCOMIL to:

- · access the data you have indicated to us;
- Request rectification of your data;
- Request deletion of your data;
- Request the limitation of the processing of your data;
- object to the processing of your data;
- Request the portability of your data to the entity you indicate.

It should be noted, however, that if there is a rule or obligation legally imposed that overlaps these rights, **TINCOMIL** will respond to the impossibility of executing the request, stating the reasons.
